INVENTOR hereby sells, assigns, and transfers to GOJO, its successors and assigns, the entire right, title and interest, so far as concerns the United States and the Territories and Possessions thereof and all foreign countries, in and to the inventions set forth in the application for United States Letters Patent filed on the above-indicated date, said application for United States Letters Patent, any and all other applications for Letters Patent on said inventions in the United States including, but not limited to, any patent applications filed therefrom or claiming priority thereto, and in countries foreign to the United States, including all provisional, non-provisional, divisional, renewal, extension, reexamination, substitute, continuation, continuation-in-part, reissue, and convention applications based in whole or in part upon said inventions or upon said applications, and any and all Letters Patent and reissues and extension of Letters Patent granted for said inventions or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said applications and said Letters Patent.

2. GOJO is hereby authorized to file patent applications in any or all countries on any or all said inventions in the name of the INVENTOR or in the name of GOJO or otherwise, as GOJO in its sole discretion may deem advisable, under the International Convention or otherwise.

3. The Commissioner of Patents of the United States of America and the empowered officials of all other governments are hereby authorized to issue or transfer all said Letters Patent to GOJO in accordance herewith.

4. This Assignment is being made under covenant, not only that full power to make the same is had by the INVENTOR, but also that, at the time of execution of this Assignment, such assigned right is not encumbered by any grant, license, governmental restriction, or other right heretofore given.

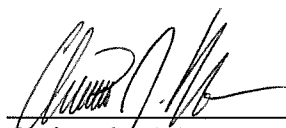

7. INVENTOR hereby instructs GOJO's attorneys to enter the corresponding application number and filing date of the afore-referenced patent application(s), if not already entered above, prior to recording this assignment, to have the same effect as if entered prior to my signature.
