AND WHEREAS the Assignees are desirous of obtaining a Patent or Patents in the United Kingdom and in other countries for the said Invention or Inventions




AND I THE INVENTOR HEREBY assent to the making of Applications for such Patents by the Assignees jointly with the Inventor.

IN WITNESS THEREOF the parties have agreed that this Assignment becomes effective the day and year first written above.


