ASSIGNMENT

WHEREAS, We, Robert Nägeli, a citizen of Switzerland, residing at Im Bungert 16, CH-8451 Kleinandelfingen, Switzerland; Ludek Malina, a citizen of Switzerland, residing at Gartenstrasse 1, CH-8302 Kloten, Switzerland; and Gabriel Schneider, a citizen of Switzerland, residing at Weinbergstrasse 52, CH-8400 Winterthur, Switzerland, (hereinafter referenced as ASSIGNORS), have invented a certain new and useful invention entitled FASTENING MEANS FOR A COMPRESSION MODULE ON A SPINNING MACHINE, for which an application for Letters Patent of the United States has been filed in the United States Patent and Trademark Office on November 21, 2014, as Application Serial No. 14/402,938;

And we hereby agree, at the expense of ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue, and substitute applications, make lawful oaths and declarations, and generally do everything possible to vest title in ASSIGNEE and to aid ASSIGNEE to obtain and enforce proper protection for said invention in all countries.

And we hereby agree to transfer a like interest, upon the request of said ASSIGNEE, its successors, assigns and legal representatives, and without further remuneration, in and to any improvements, and applications for patent based thereon, growing out of or related to the said invention; and to execute any papers by the said ASSIGNEE, its successors, assigns and legal


representatives, deemed essential to ASSIGNEE's full protection and title in and to the invention hereby transferred.
