Further, Assignor agrees that, upon request and without further compensation, but at no expense to Assignor, his legal representatives and assigns will do all lawful acts, including the execution of papers and the giving of testimony, that may be necessary or desirable for obtaining, sustaining, reissuing, or enforcing Design Patent in the United States and throughout the world for said design, and for perfecting, recording, or maintaining the title of Assignee, its successors and assigns, to said design, said application, and any Design Patent granted for said design in the United States and throughout the world.

Assignor represents and warrants that he has not granted and will not grant to others any rights inconsistent with the rights granted herein.

Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States and of all foreign countries to issue any Design Patent granted for said design, whether on said application or on any subsequently filed division, continuation, continuation-in-part or reissue application, to Assignee, its successors and assigns, as the assignee of the entire interest in said design.



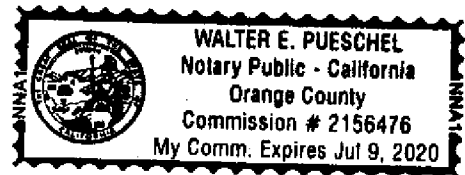
