NOW IT IS HEREBY AGREED as follows:

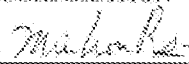
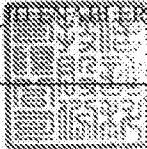

IN WITNESS WHEREOF, each of the parties hereto has caused this Assignment to be duly executed and delivered by its representative as of the date first above written.

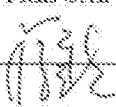
