2. ASSIGNOR represents and warrants that ASSIGNOR is the sole and exclusive lawful owner of all rights, title, and interest in and to PATENTS AND PATENT APPLICATIONS; that the PATENTS AND PATENT APPLICATIONS have not been assigned or otherwise transferred, encumbered or affected by ASSIGNOR; and that ASSIGNOR has the authority and full right to make this ASSIGNMENT.
