## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK AND PATENTS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK AND PATENTS (this "*Release*"), dated as of April 11, 2017 (the "*Effective Date*"), is made by WEBSTER BANK, NATIONAL ASSOCIATION (the "*Secured Party*").

WHEREAS, Plas-Pak Industries, Inc., a Connecticut corporation (the "*Borrower*"), granted the Secured Party a security interest (the "*Security Interest*") in certain intellectual property that included the United States trademark identified on Schedule A hereto (the "*Trademark*") and the United States patents identified on Schedule B hereto (the "*Patents*") under a Patent and Trademark Security Agreement, dated as of October 3, 2008, by and between the Borrower and the Secured Party, and an Amended and Restated Patent and Trademark Security Agreement, dated as of October 3, 2010, by and between the Borrower and the Secured Party (together, the "*Security Agreement*");

WHEREAS, the Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office at Reel/Frame 3865/0651 on October 6, 2008;

WHEREAS, the Security Interest was also recorded in the Patent Division of the United States Patent and Trademark Office at Reel/Frame 21630/0933 on October 6, 2008; at Reel/Frame 21965/0365 on November 20, 2008; and at Reel/Frame 25285/0461 on December 15, 2010;

WHEREAS, the Borrower requests that the Secured Party terminate and release the entirety of its Security Interest in the intellectual property of the Borrower, including the Trademark and the Patents; and

WHEREAS, the Secured Party grants such request.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Secured Party hereto agrees as follows:

1. Release. The Secured Party hereby terminates and releases the Security Interest in the intellectual property of the Borrower, including the Trademark and the Patents, and hereby transfers and assigns to the Borrower any and all of its right, title and interest in and to the Trademark and the Patents.

2. Further Assurance. At the request of the Borrower, the Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

3. Recordation. The Secured Party hereby authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable United States government officer record this Release.
