RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Release") is made as of April 19, 2017 (the "Effective Date") by SILICON VALLEY BANK, ("Bank"), in favor of ENTRADA, INC., a Delaware corporation (the "Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement by and between Grantor and Bank dated as of June 19, 2013 (the "IPSA"), Grantor granted to Bank a continuing security interest in and to all of Grantor's right, title and interest in and to the Patents and Trademarks (as defined in the IPSA), which, includes, without limitation, the United States patent registrations (the "Patents") set forth on Exhibit A attached hereto and United States trademark registration (the "Trademark") set forth on Exhibit B attached hereto, in each case, together with the goodwill associated therewith;

WHEREAS, the IPSA was recorded with the United States Patent and Trademark Office, Patent Division on September 9, 2013, at Reel/Frame: 31189/003541; and

WHEREAS, Grantor has paid all of the outstanding indebtedness to Bank secured by Grantor's right, title in and interest in the Patents and Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby terminates the IPSA and hereby terminates, cancels and releases any and all security interests it has against the Patents and Trademarks.



This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and interpreted in accordance with, the laws of the State of California.

This Release may be executed in one or more counterparts, and by the different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original, but all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page of this Release by facsimile or email shall be as effective as delivery of a manually executed counterpart of this Release.
