UPON SAID CONSIDERATION, the Assignor hereby covenants and agrees with the said Assignee that it will not execute any writing or do any act whatsoever conflicting with these presents, and that it will, at any time upon request, without further or additional consideration, but at the expense of the said Assignee, execute such additional assignments and other writings and do such additional acts as said Assignee may deem necessary or desirable to perfect the Assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, continuations, continuations-in-part, continuing prosecutions, divisionals, renewals, reissues, reexamined or extended design registrations and Letters Patent of the EUIPO, United States, or of any and all foreign countries, on said Design and Patent Rights, and execute confirmatory assignments or acknowledgments of this assignment as necessary for full enjoyment of the Design and Patent Rights and for recording in foreign patent offices, and in enforcing any rights or choses in action accruing as a result of such Design and Patent Rights, by giving testimony in any proceedings or transactions involving such Design and Patent Rights, and by executing preliminary statements and other affidavits, it

being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of both parties;




