**RELEASE OF  
GRANT OF SECURITY INTEREST  
IN PATENTS AND TRADEMARKS**

WHEREAS, Sharp Packaging Systems, I.L.C., a Wisconsin limited liability company (the "Pledgor"), is the owner of the trademark applications and registrations listed on Schedule A attached hereto, (all such trademarks, registrations and applications, collectively, the "Trademarks") and is the owner of the patents and patent applications listed on Schedule A attached hereto (all such patents, registrations and applications, collectively, the "Patents"); and

WHEREAS, BMO Harris Bank National Association, a national banking association, successor-in-interest to M&I Marshall & Ilsley Bank (the "Secured Party"), hereby wishes to release its security interest in the Trademarks and Patents;

WHEREAS, in order to secure certain indebtedness, the Pledgor entered into a Security Agreement (as amended, modified, restated or supplemented from time to time) dated as of April 28, 2006, in favor of M&I Marshall & Ilsley Bank, as secured party, and pursuant thereto executed and delivered a Confirmatory Assignment of Security Interest in United States Patents, Trademarks and Copyrights ("Grant") as recorded on May 17, 2006 with the United States Trademark Office on Reel 003311 at Frame 0148 and with the United States Patent Office on Reel 017626 and Frame 0700, respectively, pursuant to which the Pledgor granted to the secured party, according to the terms of the Security Agreement and the Confirmatory Assignment of Security Interest in United States Patents, Trademarks and Copyrights, a security interest in all of its right, title and interest in and to the Trademarks and Patents;

WHEREAS, the Pledgor entered into a Security Agreement (as amended, modified, restated or supplemented from time to time) dated as of June 30, 2011 in favor of Bank of America, N.A., as secured party and pursuant thereto executed and delivered a Patent and Trademark Security Agreement as recorded on July 12, 2011 with the United States Trademark Office on Reel 004580 at Frame 0240, and with the United States Patent Office on Reel 026583 at Frame 0791, respectively, pursuant to which the Pledgor granted to the secured party, according to the terms of the Security Agreement and the Patent and Trademark Security Agreement, a security interest in all of its right, title and interest in and to the Trademarks and Patents;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party does hereby release and relinquish, and to the extent that the Secured Party has acquired any right, title or interest in or to any of the Patents or Trademarks, does hereby reassign to the Pledgor, without representation or warranty, all of the Secured Party's right, title and interest in and to the Trademarks and Patents listed on the attached Schedule A, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, and does hereby agree that the filing of the Grant in the United States Patent and Trademark Office as aforesaid may be removed of record.
