This NOTICE OF SUCCESSION OF AGENCY (this "Notice"), dated as of May 1, 2017 (the "Effective Date"), is executed by Bank of America, N.A., in its capacity as Administrative Agent under the Original Agreements (as defined below) (the "Prior Agent"), and JPMorgan Chase Bank, N.A., in its capacity as Administrative Agent under the Current Agreements (as defined below) (the "Successor Agent").

WHEREAS, pursuant to that certain Credit Agreement, dated as of November 30, 2014, by and among MA FINANCECO., LLC, Prior Agent and certain other parties thereto (the "Original Credit Agreement"), the Prior Agent and certain grantor parties identified on the signature page hereto (the "Grantors") entered into that certain Security Agreement, dated as of November 20, 2014 (the "Original Security Agreement"), and the Patent Security Agreement, dated as of July 12, 2016 (the "Patent Security Agreement"), pursuant to which the Grantors granted a security interest in and to certain collateral;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Patent Office on July 12, 2016 at Reel/Frame 039136/0241, with respect to the patents identified on Schedule A attached hereto;

Nothing herein shall be deemed to terminate, interrupt or impair the continuity of the security interest in the collateral originally granted to the Prior Agent under the Patent Security Agreement, which security interest is now succeeded by and transferred to the Successor Agent.
