## TERMINATION OF SECURITY INTEREST IN PATENTS

May 1, 2017

WHEREAS, each of SUNNY DELIGHT BEVERAGES CO., a Florida corporation, and SD IP HOLDINGS COMPANY, a Delaware corporation, each having an office at 10300 Alliance Road, Suite 500, Cincinnati, OH 45242 (collectively, the "Grantors") has granted to TCW ASSET MANAGEMENT COMPANY LLC, a Delaware limited liability company (f/k/a TCW ASSET MANAGEMENT COMPANY, a California corporation), having an office at The John Hancock tower, 200 Clarendon Street, 51<sup>st</sup> Floor, Boston, MA 02116 (as Agent for itself and certain lenders, in such capacity, together with its successors and assigns the "Grantee"), a continuing security interest (the "Security Interest") in (i) all of Grantors' right, title and interest in, to and under the patents and patent applications set forth on Exhibit A attached hereto (the "Patents"), (ii) any and all rights and privileges arising under applicable law with respect to the Grantors' use of the Patents, (iii) any and all inventions and improvements described and claimed therein, and (iv) any and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof, (v) all income, fees, royalties, damages, claims and payments now or hereafter due and/or payable thereunder and with respect thereto, including, without limitation, damages and payments for past, present and future infringements thereof, (vi) any and all rights corresponding thereto throughout the world, and (vii) any and all rights to sue for past, present or future infringements thereof (the foregoing, collectively, the "Collateral"), pursuant to, among other things, that certain Assignment for Security -- Patents, dated as of February 2, 2016 (as amended, amended and restated, supplemented or otherwise modified and in effect from time to time, the "Agreement"), which was recorded at the United States Patent and Trademark Office on February 29, 2016 on Reel 037993, Frame 0292 and at the Canadian Intellectual Property Office on March 31, 2016; and

WHEREAS, the Grantee has agreed to terminate the Security Interest.


NOW, THEREFORE, the Grantee hereby agrees as follows:

1. All capitalized terms used herein but not otherwise defined shall have the meanings ascribed to them in the Agreement.
2. The Grantee hereby releases, discharges, waives and relinquishes all its rights, powers, privileges and remedies with respect to the Agreement and the Security Interest, and reassigns to the Grantors any and all interest in the Collateral, including, without limitation, the Patents set forth on Exhibit A attached hereto. The Grantee agrees that, upon request of the Grantors or any successor-in-interest or assignee thereof, and at the Grantors' sole cost and expense, the Grantee will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the Grantors, or any successor-in-interest or assignee thereof, to effectuate the release of interests contemplated herein.
