AND I HEREBY AUTHORIZE AND REQUEST the Commissioner of Patents and Trademarks to issue any and all Letters Patent of the United States for said invention, or resulting

from said application, or from any division, reissue, or extension thereof, to PPG INDUSTRIES OHIO, INC., as sole assignee.
