Cool Planet Energy Systems, Inc., a Delaware corporation, having a principal place of business at 6400 South Fiddlers Green Circle, Greenwood Village, CO 80111 ("ASSIGNEE").

1.0 BACKGROUND

1.1 ASSIGNORS, through each ASSIGNOR'S respective fiduciary duty and/or employment with ASSIGNEE, as either fiduciary and/or employee, as the case may be, jointly invented certain new and useful improvements as described and set forth in an application for Letters Patent of the United States titled "BIOCHAR AGGREGATE PARTICLES," U.S. Patent Application Serial No. 15/423,563 filed on February 2, 2017 and any U.S. and foreign conversion or counterpart patent applications to which priority is claimed. 2.0 ASSIGNMENT

2.1 ASSIGNOR sells, assigns and transfers to ASSIGNEE all exclusive right, title and interest in and to the Invention and all Letters Patent that may be granted from the Invention in the United States, including any conversions, continuation, division, renewal, substitute or reissue thereof for the full term or terms for which the patents may be granted. 2.5 ASSIGNORS hereby covenant that no assignment, sale, agreement or encumbrance has been or will be made or entered into that would conflict with this assignment of the Invention and all the related patents and patent applications filed therefrom.






