**SHORT-FORM PATENT SECURITY AGREEMENT**

SHORT-FORM PATENT SECURITY AGREEMENT, dated as of May 17, 2017 (this "Grant") among REICHHOLD LLC 2, a Delaware limited liability company (the "Grantor"), and U.S. BANK TRUSTEES LIMITED, having its address at 125 Old Broad Street, 5th Floor, London, EC2N 1AR, United Kingdom (the "Security Agent"). Unless otherwise defined herein or the context otherwise requires, terms used in this Grant, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreement (as hereinafter defined).

WHEREAS, pursuant to the US Pledge and Security Agreement, dated as of May 17, 2017, made by the Grantor, the other assignors from time to time party thereto and the Security Agent (as amended, modified, restated and/or supplemented from time to time, the "Security Agreement"), the Grantor pledged and granted to the Security Agent, for the benefit of the Primary Secured Creditors, a Security Interest in certain Collateral, including Intellectual Property;

WHEREAS, such Security Interest includes such Grantor's Registered Intellectual Property, including the Patents set forth on Schedule A (such scheduled Patents, the "Patent Collateral"); and

WHEREAS, the Grantor has duly authorized the execution, deliver and performance of this Grant;


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and subject to the terms and conditions of the Security Agreement, the Grantor hereby pledges to the Security Agent as collateral security, and grants to the Security Agent a security interest in, to and under (i) the Patent Collateral, (ii) all Proceeds (as such term is defined in the Security Agreement) and products of the Patent Collateral, and (iii) all rights to sue at law or in equity for any infringement or other impairment thereof of any of the Patent Collateral.

This Grant has been granted in conjunction with the Security Interest granted to the Security Agent under the Security Agreement. The rights and remedies of the Security Agent with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.


