ASSIGNMENT AGREEMENT

IN THIS AGREEMENT, made and entered into as of the First day of January, 2017 ("Effective Date"), Weatherford Technology Holdings, LLC, a Delaware limited liability company having a place of business at 2000 St. James Place, Houston, Texas 77056 (hereinafter "WTH"), Weatherford/Lamb, Inc., a company incorporated in the United States having a place of business at 2000 St. James Place, Houston, Texas 77056 (hereinafter "WLAMB", together with WTH "ASSIGNORS") and Weatherford Netherlands B.V., a Netherlands limited liability company having a registered office at Schrijnwerkersweg 6, 1786 PC, Den Helder (hereinafter referred to as "ASSIGNEE").

RECITALS

WHEREAS, ASSIGNORS are in the business of managing and maintaining the legal protection of Intellectual Property rights on behalf of legal entities within the group of companies owned partially or wholly, directly or indirectly by Weatherford International plc.

WHEREAS, ASSIGNEE is in the business of developing, manufacturing, and providing specialized products, such as eccentric noses, drilling jar clamps, liner plug systems, cement plugs and stabbing guides, as well as continued production and sales of the Klepo inflatable thread protector (the "Elastomer Business") to the oil and gas industry.

WHEREAS, ASSIGNORS and ASSIGNEE have in a prior understanding agreed that ASSIGNORS manage and file for patent protection in ASSIGNORS names for development of intellectual property related to the Elastomer Business undertaken and economically owned by ASSIGNEE, and that according to this understanding ASSIGNORS retained only legal title to the patents related to the Elastomer Business.

WHEREAS, ASSIGNORS and ASSIGNEE now wish to assign all of ASSIGNORS' rights related to the development work undertaken as part of the Elastomer Business to ASSIGNEE.

THEREFORE, in consideration of the mutual covenants hereinafter set forth, the Parties do hereby agree as follows:

1. ASSIGNORS hold all legal rights, title, and interest in and to each and every patent and patent application listed in **Attachment A**, the inventions disclosed and claimed therein, and all other patents and applications that rely on the patents and patent applications listed in **Attachment A** for priority ("the Patents").
2. ASSIGNEE desires to acquire and ASSIGNORS are willing to assign to ASSIGNEE all of ASSIGNORS' rights, title, and interest in and to the Patents and any inventions disclosed and claimed therein.
3. ASSIGNORS hereby transfer, grant, convey, assign, and relinquish exclusively to ASSIGNEE all of ASSIGNORS' rights, title, and interest in and to the Patents, the inventions

described and claimed therein, and all accrued causes of action for damages for infringement thereof.

4. On the Effective Date, ASSIGNEE shall pay to each ASSIGNOR the sum of \$1,000 dollars (\$) by certified check or wire transfer, as specified by ASSIGNORS.
5. ASSIGNORS shall execute and deliver to ASSIGNEE the Assignment in **Attachment B** hereto, and, from time to time after the date hereof upon the request of ASSIGNEE, such further conveyance instruments as may be necessary or desirable to evidence more fully the transfer of ownership of all the Patents to ASSIGNEE, or the original ownership of all the Patents on the part of ASSIGNORS, to the fullest extent possible. ASSIGNORS further agree to provide testimony in connection with any proceeding affecting the rights, title, interest, or benefit of ASSIGNEE in and to the Patents and to perform any other acts deemed necessary to carry out the intent of this Agreement. ASSIGNEE shall reimburse ASSIGNORS for any and all costs reasonably incurred by ASSIGNORS in performance under this paragraph.
6. In furtherance of this Agreement, ASSIGNORS hereby acknowledge that, from the Effective Date forward, ASSIGNEE has succeeded to all of ASSIGNORS rights, title, and standing to receive all rights and benefits pertaining to the Patents, institute and prosecute all suits and proceedings, and take all actions that ASSIGNEE, in its sole discretion, may deem necessary or proper to collect, assert, or enforce any claim, right, or title of any kind under any and all of the Patents, whether arising before or after the Effective Date, defend and compromise any and all such actions, suits, or proceedings relating to such transferred and assigned rights, title, interest, and benefits, and do all other such acts and things in relation thereto as ASSIGNEE, in its sole discretion, deems advisable.
7. ASSIGNORS represent and warrant that no consents of any other parties are necessary or appropriate under any agreements concerning any of the Patents in order for the transfer and assignment of any of the Patents under this Agreement to be legally effective.
8. ASSIGNORS represent and warrant that, to the best of ASSIGNORS' knowledge, upon consummation of this Agreement, ASSIGNEE shall have good and marketable title to the Patents, free and clear of any and all liens, mortgages, encumbrances, pledges, security interests, licenses, or charges of any nature whatsoever.
9. This Agreement shall inure to the benefit of, and be binding on, the Parties hereto together with their respective legal representatives, successors, and assigns

10. This Agreement shall be governed by and construed in accordance with the laws of the State of Texas (excluding conflicts of law rules) and of the United States.
