**RELEASE OF SECOND LIEN SHORT FORM INTELLECTUAL PROPERTY  
SECURITY AGREEMENT**

This Release of Second Lien Short Form Intellectual Property Security Agreement (this “Release”) is made as of April 14, 2017, by WILMINGTON TRUST, NATIONAL ASSOCIATION (successor agent), in its capacity as agent for the Lenders under (and as defined in) the Security Agreement and Second Lien Agent Succession Agreement referred to below (the “Collateral Agent”) for the benefit of ANSWERS CORPORATION, a Delaware corporation, with principal offices at 6665 Delmar Boulevard, Suite 3000, St. Louis, Missouri 63130 (the “Grantor”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement.

**W I T N E S S E T H:**

WHEREAS, the Grantor and the Collateral Agent are parties to that certain (i) Security Agreement, dated as of October 3, 2014 (as amended, restated or otherwise modified through the date hereof, the “Security Agreement”); (ii) Second Lien Short Form Intellectual Property Security Agreement, dated as of October 3, 2014 (as amended, restated or otherwise modified through the date hereof, the “Short Form IP Security Agreement”); and (iii) Second Lien Agent Succession Agreement, dated as of September 7, 2016 (as amended, restated or otherwise modified through the date hereof, the “Succession Agreement”), pursuant to which the Grantor has granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in all of the right, title and interest of the Grantor in and to the Patents (as defined in the Second Lien Intellectual Property Security Agreement, dated as of October 3, 2014 (as amended, restated or otherwise modified through the date hereof)), including the patents set forth on Schedule I hereto;

WHEREAS, the Short Form IP Security Agreement was recorded in the United States Patent and Trademark Office on October 3, 2014 at Reel 033882 and Frame 0754; and

WHEREAS, Grantor has requested that the Collateral Agent release the security interest originally recorded at Reel 033882 and Frame 0754 in favor of Credit Suisse AG, Cayman Islands Branch and assigned to the Collateral Agent at Reel 039684 and Frame 0237 , and the Collateral Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in and to the Patents.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The Collateral Agent does hereby terminate, release and discharge the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement or Short Form IP Security Agreement to the Patents and any right, title or interest of the Collateral Agent in such Patents shall hereby terminate, cease and become void. The Collateral Agent hereby assigns, transfers and conveys any and all right, title or interest of the Collateral Agent in the Patents to the Grantor.

2. This Release may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.

3. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
