For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Kärcher North America, Inc., a Delaware corporation with its principal place of business at 4555 Airport Way, Denver, Colorado 80239 (“Assignor”), hereby assigns to Sapphire Scientific, Inc., an Arizona corporation, with an office at 2604 Liberator, Prescott, Arizona 86301, (“Assignee”), its successors, assigns or other legal representatives, Assignor’s entire right, title and interest in and to all of its United States and foreign utility and design patents that are Acquired Assets, together with any and all applications that are Acquired Assets, including but not limited to those identified on Schedule A hereto, and any and all extensions, re-examinations and reissues of such patents, patents of addition, patent applications, divisions, continuations, continuations-in-part, and all subsequent filings in any country or jurisdiction claiming priority there from, including the inventions disclosed therein and the subject matter of any and all claims which may be obtained in such patents or applications, that are Acquired Assets as defined pursuant to the terms of a certain Asset Purchase Agreement, dated as of even date herewith, by and between Assignor and Assignee (the “Patents”), the same to be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives to the full end of the term for which each of said Patents is granted, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

Assignor covenants that it has the full right to convey the entire interest assigned herein, and that it has not executed and will not execute any agreement in conflict herewith, and agrees that it will communicate to Assignee, its successors, assigns or other legal representatives, all facts known to it respecting the property conveyed herewith, whenever requested, and at the expense of Assignee, its successors, assigns or other legal representatives to testify in any legal proceedings, sign all lawful papers, execute and deliver all divisional, continuing, reissue and foreign applications, make all rightful oaths and do all lawful acts requisite for the application for such divisional, continuing, reissue or foreign applications, or the procuring thereof, and that if and when the Assignee, its successors, assigns or other legal representatives desire to file a disclaimer relating thereto, Assignor will upon request, sign and deliver all lawful papers requisite for the filing of such disclaimer. Assignor further covenants and agrees that it will, at any time upon request, do everything reasonable to aid the Assignee, its successors, assigns or

other legal representatives, either in its own name or that of Assignee, to apply for, obtain and enforce proper patent protection in all countries, including priority rights granted in foreign countries according to all the laws and treaties in force, all without further consideration but at the expense of Assignee, its successors, assigns or other legal representatives.


Assignor further assigns to Assignee, its successors, assigns or other legal representatives, any and all claims for damages by reason of past and continuing infringement of said Patent, and the right to sue for and collect the same for its own use and benefit and that of its successors, assigns or other legal representatives.
