And, **ASSIGNOR** individually or collectively as applicable, hereby authorize and request the Commissioner of Patents and Trademarks to issue any and all Letters Patents of the United States on said invention and discoveries to **ASSIGNEE** as **ASSIGNEE** of the entire interest.
