Contract and Parties

This is a contract made on the 12th Day of December 2014, under the law of England and Wales and subject to the jurisdiction of the civil courts under that law, between

SURGICAL SYNERGY LIMITED, a company registered in the UK (Reg No 06866406)
with Registered Office at 156 Pentre Nicklaus, Llanelli, Carmarthenshire, SA15 2DF

AND

MARTIN NORTON TONBRIDGE KNIGHT
of Grange Court Park, Grange Road, Tenterden, Kent, TN30 6EE
and

ROGER BERNARD JOHN
of 156 Pentre Nicklaus, Llanelli, SA15 2DF

Purpose

Martin Knight and Roger John have developed of intellectual capital / property in the design and definition of the Medusascop, magazine, functionelles, surgeon's chair and other related devices and subassemblies. There are a number of patents in place to protect these ideas and innovations and the number is expected to increase. The costs of registration and handling for each of the patents in place have been funded entirely by Surgical Synergy Limited (SSL). The patents themselves, however, are registered in the joint names of Dr Martin Knight and Mr Roger John, both Directors and Members of the company. Both these founder members now wish to vest all Intellectual Property (concepts, functional descriptions and designs, present and future) pertaining to the Medusascop and its subs-assemblies and peripheral equipment in Surgical Synergy Limited to facilitate the attraction of equity and thus enable SSL to maximize its value to the benefit of all shareholders.

Consideration

It is difficult to put any specific financial value on the patents and intellectual capital currently. This will only be manifested at the point where technical feasibility and benefits assessment can be assessed through a working prototype and then realized through development of the instrument so that it can either be taken to the market or demonstrably of commercial value. Indeed, this has been recognized as the costs incurred have not been capitalized and no value in the SSL accounts.

The Contract

WHEREAS

1. DR MARTIN NORTON TONBRIDGE KNIGHT and MR ROGER BERNARD JOHN hereby transfer all value, rights, benefits (current and future) in all the intellectual property, patents registered and those to currently envisaged related both directly and indirectly to the new concept endoscope and the "Surgeon's Chair", known to SSL as the Medusascop, to the sole and beneficial ownership of SURGICAL SYNERGY LIMITED.

4. The Company shall have no claim against either individual for infringements of copyright, patents, intellectual capital arising from the transfer and subsequent use of the IP transferred under this contract.
5. There are no retentions by the individuals in rights transferred nor any retained rights over scope of usage, future disposal nor any beneficial restrictions.

THEN

6. SURGICAL SYNERGY LIMITED has provided a payment of £10 to each of DR MARTIN NORTON TONBRIDGE KNIGHT and MR ROGER BERNARD JOHN in consideration of the unencumbered and unconstrained assignment of all rights in the intellectual property described above. Both individuals will continue to benefit from such intellectual property only through their continuing shareholdings in the company.
