
**ASSIGNMENT**

No. 14/035,593, filed September 24, 2013, and in and to said provisional and utility applications, preparatory to obtaining Letters Patent of the United States thereon, and in and to said applications and any Letters Patent that may be granted in pursuance of said applications and any divisional, continuation or continuation-in-part applications thereof, and in and to any reissue or re-examination of any such patent, and in and to any patent applications which may be filed on said invention in countries foreign to the United States and any Letters Patent granted thereon.

We further authorize said corporation to apply for foreign patents on said invention in its own name or through its designees, including subsidiaries, related companies or assignees, under the International Convention or otherwise, and we further agree to execute all papers, including those required for the United States and foreign applications, and to perform such other proper acts as said company may deem necessary to secure to said corporation or its designees the rights herein assigned.
