1.0 INVENTIONS.

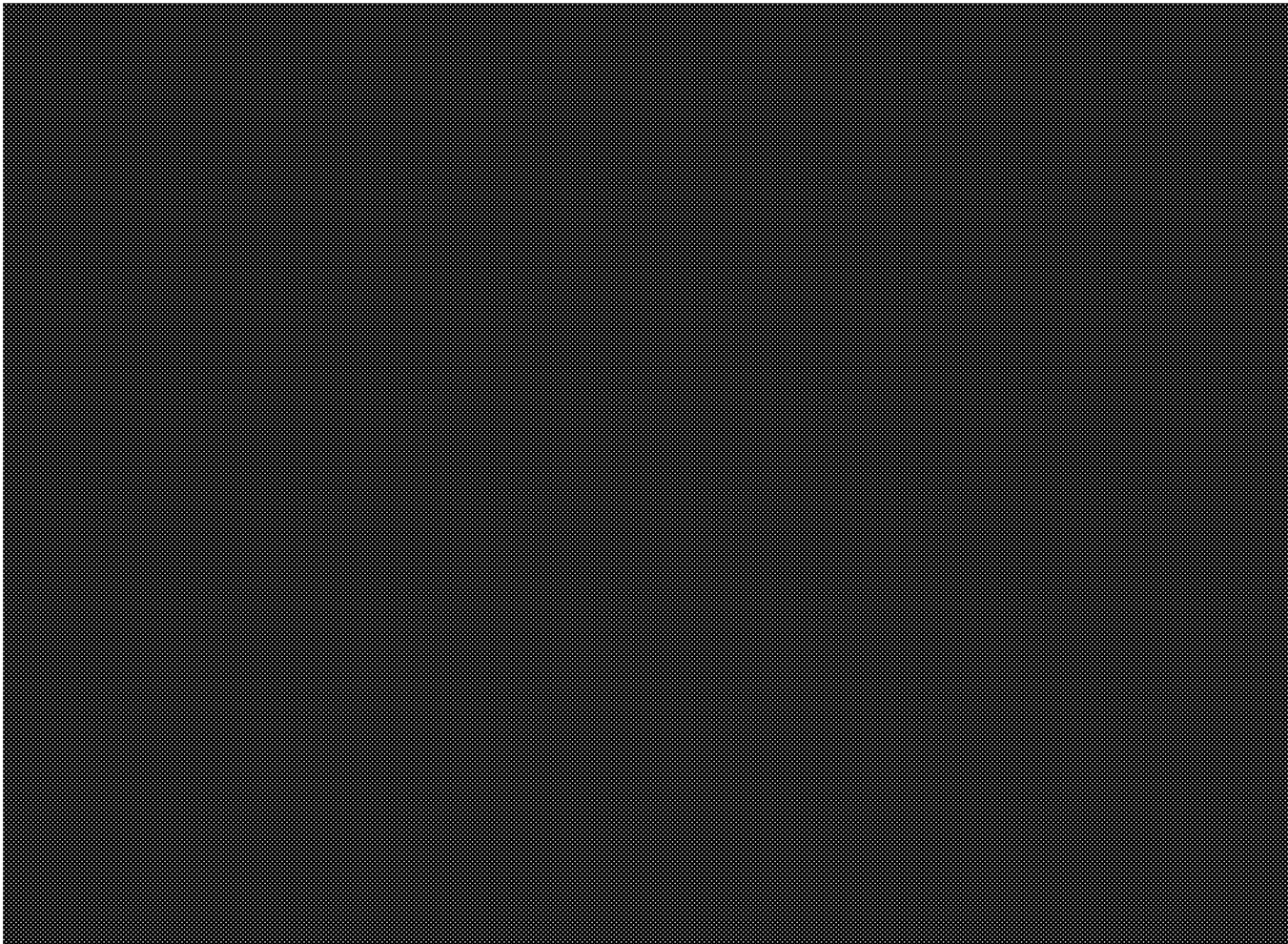

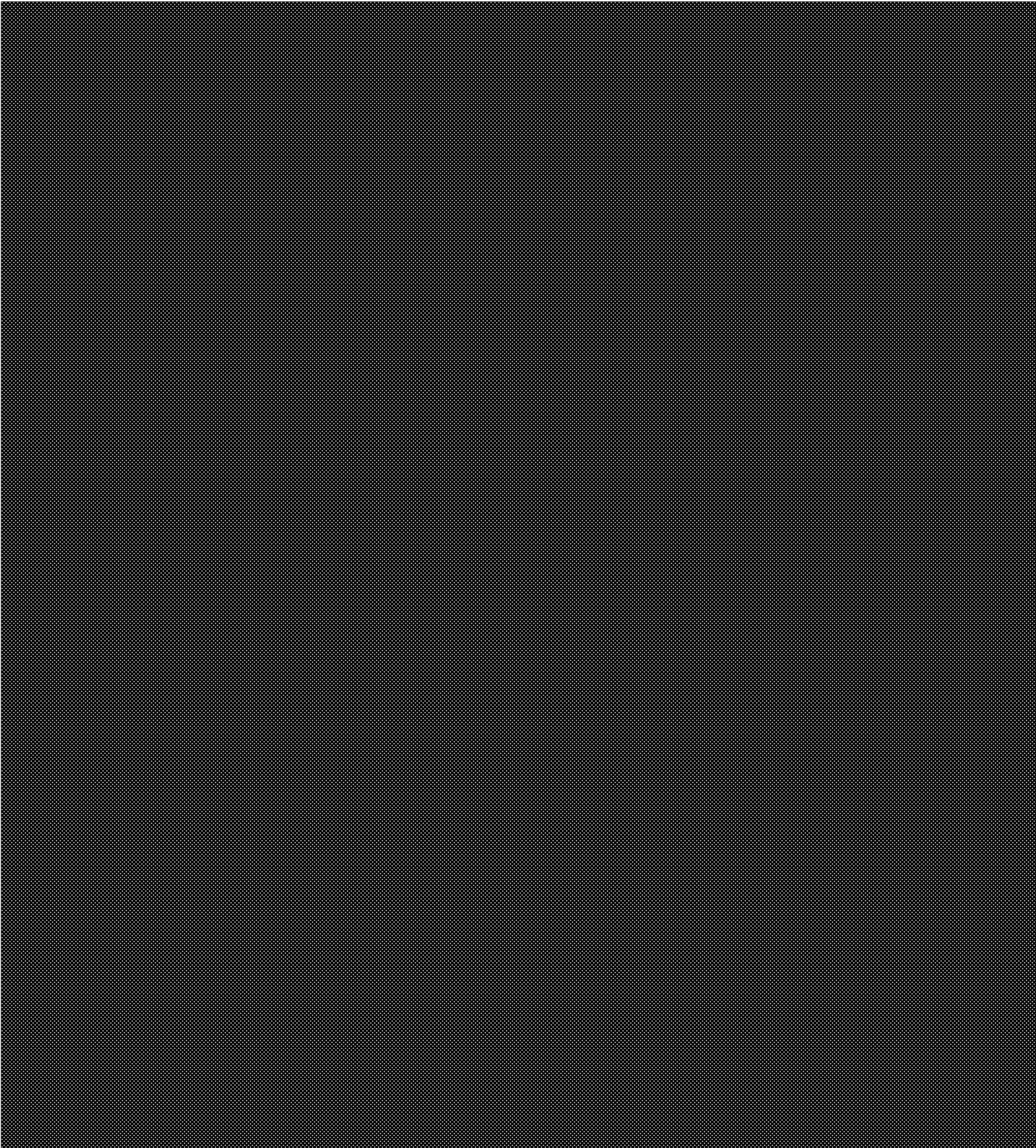






7.0 VOLUNTARY AGREEMENT.

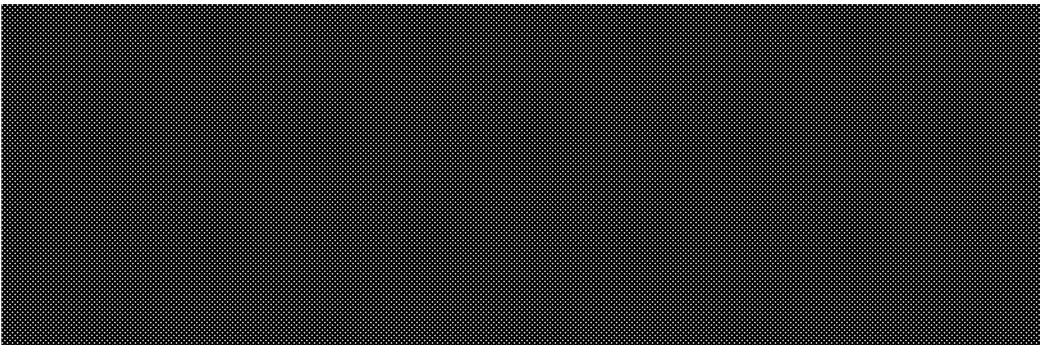

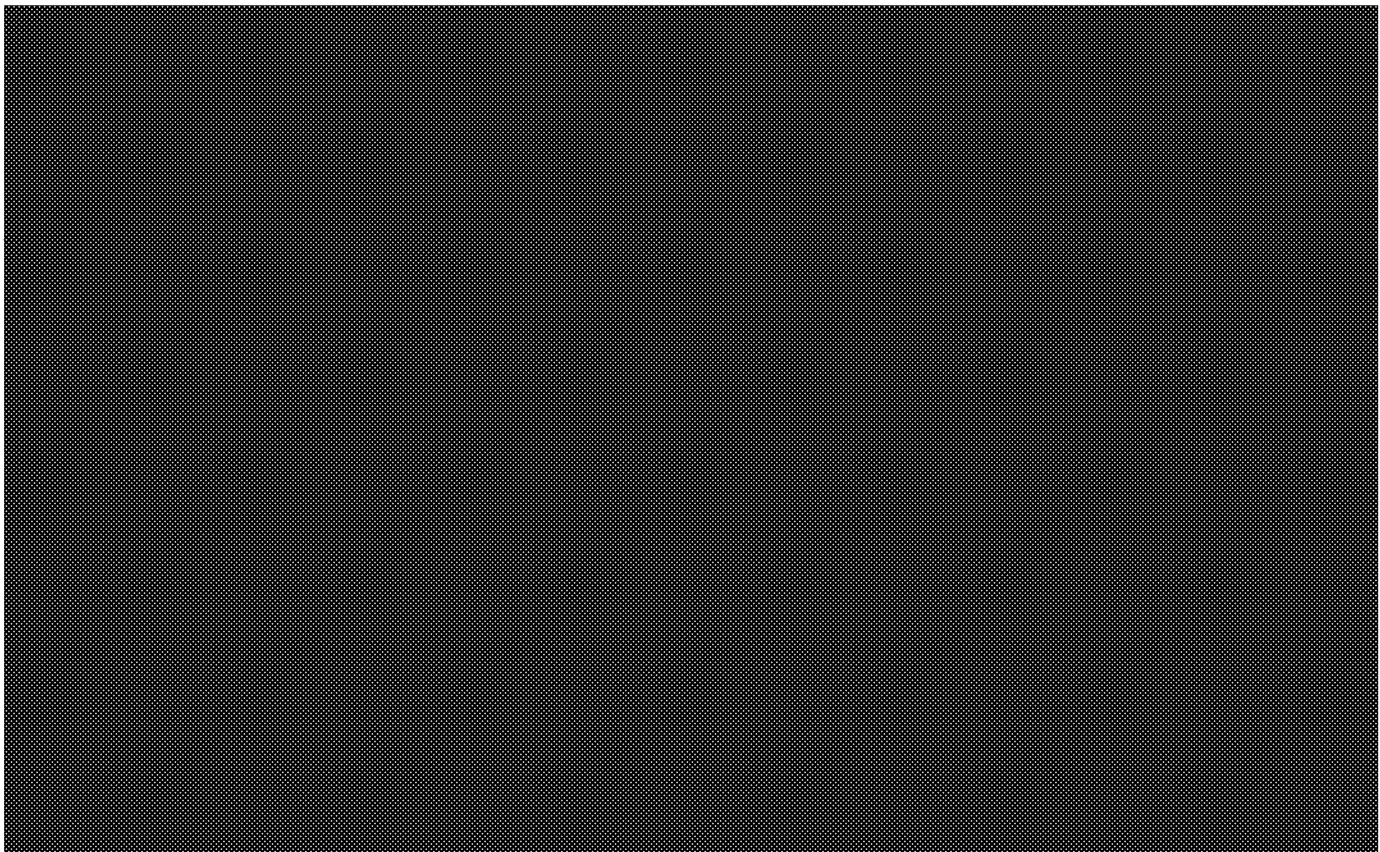
