AN ENVIRONMENTAL CONTROL SYSTEM WITH AN OUTFLOW HEAT EXCHANGER

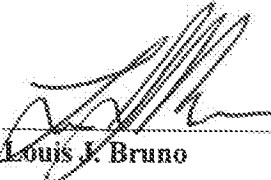
which is set forth in an application in the United States executed on even date herewith:
