PURCHASE AGREEMENT

THIS AGREEMENT ("Agreement") made as of this 31st day of May, 2017 by and between **GEORGE CASTLE** of Terryville, Connecticut, hereinafter called the "Seller", **DANIEL CASTLE** of West Hartford, Connecticut, hereinafter called the "Purchaser".

WITNESSETH:

WHEREAS, the Seller agrees to sell and Purchaser agrees to purchase all of Seller's interest in the Connecticut limited liability company known as **ADVANCED TORQUE PRODUCTS, LLC**, with a principal office address of 56 Budney Road, Newington, Connecticut, hereinafter sometimes called the "Company".

NOW THEREFORE, in consideration of the promises herein contained, the parties agree as follows:


I. PURCHASE AND SALE OF MEMBERSHIP INTEREST.

A. Description. Subject to the terms and conditions of this Agreement, on the Closing date (as defined below), Seller shall convey, assign and transfer to Purchaser, and the Purchaser shall accept good, marketable and unencumbered title to all of Seller's Membership Interest in the Company except as set forth herein. Said interest represents 51% of the ownership in the Company.


XII. ADDITIONAL CONSIDERATION. As part consideration for the agreement, the Purchaser further agrees:

A. PATENTS. The Digital Torque patents currently held by George Castle and/or Castle Technologies, Inc. will be transferred to Daniel Castle or the Company, at Purchaser's election. The costs associated with the transfer documentation and requisite filing fees, including attorney's fees, will be borne by the Company and/or Purchaser. Said patent is more particularly described as follows: U.S. Pat. Nos. 8,434,389 and 8,991,284. In consideration for said agreement Purchaser shall enter into an agreement at the time of closing which






