of any of the foregoing assigned rights, with the right to sue for past infringement and to collect and retain damages that may have accrued prior to the effective date of this Assignment, or which have accrued or may hereafter accrue, for Moog's own use and benefit and for the use and benefit of Moog's successors, assigns and other legal representatives (all of the foregoing hereafter referred to collectively as the "Subject Property").

AND, We do hereby acknowledge and agree that Moog, as the assignee of the entire right, title and interest thereto, shall have sole control over and sole and absolute discretion with respect to any decisions regarding the Subject Property.
