WHEREAS, DePuy Orthopaedics, Inc. has changed its name to Medical Device Business Services, Inc.

WHEREAS, the Parties wish to memorialize and confirm the assignment of intellectual property rights or to assign intellectual property rights to DSP to the extent that such rights have not already been assigned;

Any Party may assign this Assignment or any and all rights and obligations contemplated herein to an affiliate or to a company acquiring substantially all of the assets of such Party to which this Assignment relates without the consent of the other Party. Any such assignment shall be subject to the terms of this Assignment. Subject to the foregoing, this Assignment shall bind and inure to the benefit of the respective Parties hereto and their successors and assigns.


