## RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS (this "Release") is made as of May 1, 2017, by CoBiz Bank, a Colorado Corporation d/b/a Colorado Business Bank (the "Bank"). Reference is hereby made to that certain Patent and Trademark Security Agreement dated March 31, 2011 (as amended, supplemented or otherwise modified through the date hereof, the "IP Security Agreement"), among the Bank, K&H Manufacturing, LLC, a Delaware limited liability company ("K&H") and Ray Allen Manufacturing, LLC, a Delaware limited liability company ("Ray Allen").

WHEREAS, pursuant to the IP Security Agreement, the Bank was granted a security interest in and to the Trademark Collateral listed in Schedule 1 of the IP Security Agreement (the "Trademark Collateral") and the Patent Collateral listed in Schedule 2 of the IP Security Agreement (the "Patent Collateral");

WHEREAS, K&H has requested that the Bank terminate and release its security interests in and to the Trademark Collateral and the Patent Collateral owned by K&H and execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office ("USPTO"); and

WHEREAS, the Bank has agreed to such termination and release.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Bank hereby releases and terminates all security interests and other interests it may have in the Trademark Collateral and the Patent Collateral owned by K&H (but, for the avoidance of doubt, not for such collateral owned by Ray Allen).


