**RELEASE OF SECURITY INTEREST

WHEREAS, pursuant to the Second Lien Patent Security Agreement, dated as of October 31, 2016, and recorded with the U.S. Patent and Trademark Office on November 10, 2016, at Reel/Frame No. 040587/0624 (the “Patent Security Agreement”), Grantor granted to the Agent a security interest in and continuing lien on all of Grantor’s right, title and interest in, to and under the Patent Collateral (as defined in the Patent Security Agreement), including, without limitation, the United States patents set forth on Schedule A attached hereto (the “Released Registered Patents”); and

WHEREAS, Grantor has requested that the Agent release its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Released Registered Patents; and

WHEREAS, the Agent now desires to terminate and release its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Released Registered Patents, and reassign any all rights, title and interest in the same to Grantor.




The Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.
