WHEREAS, pursuant to terms of that certain Security Agreement dated as of September 30, 2011 executed by Debtor in favor of the Secured party (the "Wells Fargo Security Agreement"), Debtor conveyed, pledged, assigned and transferred to the Secured Party security interests and liens in the Released Patents and Applications to secure the payment, performance and observance of certain obligations, which Wells Fargo Security Agreement was made of record in the U.S. Patent Office at Reel 027046, Frame 0291 (the Wachovia Security Agreement and the Wells Fargo Security Agreement being collectively referred to as the "Security Agreements").


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:
