WHEREAS, Assignors have invented certain new and useful improvements in SYSTEMS AND METHODS FOR PULSING AND DIRECTING A PULSED LASER BEAM TO TREAT DENTAL TISSUE, set forth in: (i) a Patent application for Letters Patent of the United States, already filed on May 5, 2017 as U.S. Application No. 15/587,525; (ii) International Patent Application No. PCT/US2017/031194, already filed on May 5, 2017; and (iii) U.S. Provisional Patent Application No. 62/332,586, already filed on May 6, 2016 ((i), (ii), and (iii) being collectively referred to herein as the "Patent Rights"); and
