BETWEEN:

- (3) **JOHNSON MATTHEY PLC**, a company incorporated in England and Wales (registered number 00033774) whose registered office is at 5th Floor, 25 Farringdon Street, London EC4A 4AB ("JOHNSON MATTHEY").

BACKGROUND

- (A) ILUMINK has assigned the patent applications in the attached schedule (the "Patents") to JOHNSON MATTHEY under an agreement dated 15 April 2016 (the "Agreement").

1. ASSIGNMENT

- 1.1 ILUMINK has assigned and hereby assigns to JOHNSON MATTHEY all rights, title and interests to and in the Patents on the terms and conditions of the Agreement including the rights to:
 - (a) apply for, prosecute and obtain patent or similar protection throughout the world in respect of the Inventions and including the right to claim priority from any of the Patents; and
 - (b) take all actions and proceedings as may be necessary and recover damages or otherwise in respect of any infringement of the rights assigned by this Agreement in respect of any infringements which occurred before the date of this Agreement.

2. GOVERNING LAW

2.1 This agreement and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales.



This agreement has been entered into on the date stated at the beginning of it.




