AND WHEREAS, in order to effect the recordal of the assignment and transfer of the Patent/Design Assets in the Territory to the Assignee, the Assignor and Assignee hereby agree to sign this Confirmatory Assignment.

NOW, THEREFORE, in consideration of the foregoing and in consideration of the mutual promises, covenants, representations, warranties and agreements contained herein and in the Agreement, the Assignor hereby confirms having sold, conveyed, assigned, and transferred to the Assignee, its successors and assigns, effective as of February 27, 2017, its entire right, title, and interest in, to and under, the Patent/Design Assets, inclusive of any continuations, divisionals, re-issuances or re-examinations thereof, all rights of priority, and any and all patents and industrial designs that may issue on any of the foregoing, and any and all right, title, interest, privileges, damages, settlements and proceeds under, relating to, or arising from, the Patent/Design Assets, including, without limitation, any claim against third parties for past, present or future infringement or misappropriation of the Patent/Design Assets, all of which or the same to be held and enjoyed by the Assignee for its own use and benefit, and for the use and benefit of its successors and assigns.
