TO WHOM IT MAY CONCERN:

The undersigned attorney provides notification of a lien under the California Code of Civil Procedure §708.110(d) in favor of Mr. Gerald D. North (hereinafter "Judgment Creditor") and against Ubiquity, Inc. (hereinafter "Judgment Debtor") on the personal property of the Judgment Debtor as of March 11, 2017, or at the latest, March 28, 2017. On, October 28, 2016, Mr. North obtained a judgment against Ubiquity, Inc. (a Nevada Corporation) in the United States District Court for the Northern District of Illinois Eastern Division (Case No. 16-CV-05698) in the amount of Seven Million, Seven Hundred Twenty Two Thousand, Two Hundred Fourteen Dollars and Ten Cents (\$7,722,214.10). This judgment was registered in the United States District Court for the Central District of California (Southern Division-Santa Ana) (Case No. 8:17-cv-00134-VAP-JCG) on January 10, 2017. On February 6, 2017, Magistrate Judge Jay C. Ghandi granted an order for appearance and examination of Ubiquity Inc.

On March 11, 2017 and pursuant to California Code of Civil Procedure §708.110(d), 415.10 and 416.10, the order was personally served on Brenden Garrison, Secretary and Treasurer of Ubiquity, Inc.. On March 28, 2017 and pursuant to California Code of Civil Procedure §708.110(d), 415.10 and 416.10, the order was personally served on Melanie Galero, Intake Clerk at Incorp Services, Inc. the designated agent for service of process with the Nevada Secretary of State. Under California Code of Civil Procedure §708.110(d), "Service of the order creates a lien on the personal property of the judgment debtor for a period of one year from the date of the order unless extended or sooner terminated by the court." California Code of Civil Procedure §680.290 defines personal property as including both tangible and intangible personal property. A patent is a type of personal property. See, 35 USCS § 261. Therefore, on March 11, 2017, or at the latest, March 28, 2017, Mr. Gerald D. North perfected a lien against all personal property (including patents) of the Judgment Debtor, Ubiquity Inc.

This notification of lien under California code of civil procedure Section 708.110(d) is intended to notify all potential purchasers, assignees, licensees and others that to the extent Ubiquity, Inc. holds any interest in the above-referenced patents, Mr. North's lien is attached thereto as of March 11, 2017, or at the latest, March 28, 2017. 




