NOTICE OF INVALID AND/OR FRAUDULENT ASSIGNMENTS

This statement is a notification by IP Development Limited ("IPDL"), having an address at 4th Floor, Chungbu bldg, 118-4 Chungdam-dong, Gangnam-gu, Seoul 135-955, Republic of Korea that several of the purported assignments or statements of ownership recorded with the U.S. Patent & Trademark Office for U.S. Patent Application No. 12/741,869, filed May 7, 2010 ("**the Application**") are invalid and/or fraudulent as detailed herein.

(i) Inventor Kyung Il Jung assigned all rights in the Application as well as other rights related to the Application to IPDL on November 22, 2010, recordation of which was submitted April 1, 2011 to the U.S. Patent & Trademark Office at Reel/Frame 026064/0183. From the time of his assignment to IPDL on November 22, 2010 up through to the present, including the execution dates of the purported assignments or (ii)-(v) as noted below, Mr. Jung was a minority shareholder of IPDL with NO right and/or power to assign any rights under the application to a third party.

(ii) The purported Assignment, recorded on March 28, 2011 at Reel/Frame 026029/0734, and signed March 21, 2011 using the name of inventor Mr. Kyung Il Jung, having a residence address of 49 beonji, Jak-dong, Ojeong-gu, Gyeonggido, Bucheon-si, 421-824, Republic of Korea, to a Jung Soon Lee, having the same address as that of Kyung Il Jung, is invalid and/or fraudulent.


(iii) The unsigned and undated purported Notice of Claim to Proceeds, recorded September 24, 2012 at Reel/Frame 029032/0738, claiming to assign rights to the Application as of an alleged execution date of April 26, 2010 from inventor Kyung Il Jung, having a residence address of 49 beonji, Jak-dong, Ojeong-gu, Bucheon-si, Gyeonggido 421-824, Republic of Korea, to a Jonathan Lee, having an address at P.O. Box 9187, Warner Robins, Georgia 31095, is invalid and/or fraudulent.

(iv) The purported Declaration and Notice of Invalid and/or Fraudulent Assignment, recorded January 25, 2013 at Reel/Frame 029708/0166, and signed January 25, 2013 by inventor Kyung Il Jung, having a residence address of 49 Jak-dong, Ojeong-gu, Bucheon-si, Gyeonggi-do 421-824, Republic of Korea, is invalid and/or fraudulent.

(v) The purported Judgment Lien, recorded January 24, 2014 at Reel/Frame 032121/0634, having an execution date of November 1, 2013 and purportedly conveying rights from inventor Kyung Il Jung to Jonathan Lee, is invalid and/or fraudulent.
