## ASSIGNMENT

Whereas, **ASSA ABLOY Inc.**, an **Oregon** corporation, whose address is **110 Sargent Drive, New Haven, CT 06511**, has acquired certain inventions and discoveries set forth in Letters Patent of the United States of America, Patent No. **9,530,264**, issued **December 27, 2016**, entitled **"Using Low Power Radio To Control A Higher Power Communication Interface"**.

1. Assign, transfer and convey to Assignee the entire right, title and interest in and to said inventions and discoveries, said Letters Patent of the United States of America, any and all other applications for Letters Patent on said inventions and discoveries in whatsoever countries, including all divisional, renewal, substitute, continuation and Convention applications based in whole or in part upon said inventions or discoveries, or upon said applications, and any and all Letters Patent and reissues and extensions of Letters Patent granted for said inventions and discoveries or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said discoveries, said applications and said Letters Patent, together with all claims for damages by reason of past infringement of said Letters Patent with the right to sue for and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives;
2. Authorize Assignee to file patent applications in any or all countries on any or all of said inventions and discoveries, in the name of Assignee or otherwise as Assignee may deem advisable, under the International Convention or otherwise;
3. Authorize and request the Commissioner of Patents of the United States of America and the empowered officials of all other governments to issue or transfer all said Letters Patent to Assignee, as assignee of the entire right, title and interest therein or otherwise as Assignee may direct;
4. Bind the heirs, legal representatives and assigns of **ASSA ABLOY Inc.**, to do, upon Assignee's request and at its expense, but without additional consideration, all acts reasonably serving to assure that the said inventions and discoveries, the said patent applications and the said Letters Patent shall be held and enjoyed by Assignee as fully and entirely as the same could have been held and enjoyed by **ASSA ABLOY Inc.**, its heirs, legal representatives and assigns if this assignment had not been made; and particularly to execute and deliver to Assignee all lawful affidavits in form and substance as may be requested by Assignee; to communicate to Assignee any and all facts known relating to said inventions and discoveries or the history thereof; and to

furnish Assignee with any and all documents, photographs, models, samples and other physical exhibits in its control or in the control of its heirs, legal representatives or assigns and which may be useful for establishing the facts of conception, disclosures, and reduction to practice of said inventions and discoveries.

5. Warrant that Assignor has not knowingly conveyed to others any right in said inventions, discoveries, applications or patents or any license to use the same or to make, use or sell anything embodying or utilizing any of said inventions or discoveries; and that Assignor has good right to assign the same to Assignee without encumbrance.
