WHEREAS, Assignors believes themselves to be the original, first and/or sole inventors of the Invention; and

WHEREAS, Assignor Mark Hayes has already executed an assignment for the Invention for related U.S. utility patent 8,833,781, which assignment has been recorded with the USPTO (Reel/Frame: 025869/0366).

WHEREAS, Rock-Slide Engineering, LLC ("Assignee"), a Utah company, desires to further clarify its position as Assignee for purposes of filing any and all continuation or continuation in part design patent applications for the Invention and/or to document acquisition by formal, recordable assignment the entire right, title, and interest in and to said Invention, and said Patent Application in the United States and throughout the world.

NOW, THEREFORE, in consideration of good and valuable consideration rendered by Assignee:

1. Assignment. Assignors hereby grant and assign unto Assignee, any right, title, and interest in the invention, including any and all patent applications based upon it. 3. Representations and warranties. Assignors represent and warrant as follows:

- (b) they have not sold or transferred the Invention to any third party;
- (c) they have the authority to enter into this agreement;

- (d) they do not believe that the Invention has been taken from any third party without authorization (e.g., a knowing copy of another company's invention);
- (e) they do not know of any permissions that have to be obtained in order for this assignment to be completed;
- (f) the Invention was not conceived or created in the course and conduct of Assignors' employment by a third party.

4. Agreement to cooperate. Assignors hereby agree, without further consideration and without expense to Assignee, to sign all lawful papers and to perform all other lawful acts which the Assignee may request in order to make this Assignment fully effective, including the furnishing of all lawful documents as requested by Assignee to further the prosecution of any patent applications relating to the invention, cooperation to the best of Assignors' abilities in executing all other lawful documents pertaining to the invention, and producing evidence in any actions or proceedings concerning the invention, including, but not limited to, nullification, reissuance, extension, and infringement proceedings.

5. Forum selection. The Parties agree that any action or lawsuit arising out of or related to this Agreement—including but not limited to any action brought to enforce the terms of this Agreement—shall be brought in the federal or state courts of the State of Utah. The Parties agree that they are subject to the personal jurisdiction of such courts for the purposes of any such lawsuit or action.

This assignment and agreement shall be binding upon any and all heirs and legal representatives of Assignors.




