Authorizes and requests the Commissioner of Patents and Trademarks of the United States and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications, to issue said application (including without limitation any division(s), continuation(s) (in whole or in part), substitute(s), or reissue(s) thereof) to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

Agrees to execute all papers and documents, including without limitation applications, declarations, oaths, petitions, and other papers, and entirely at the ASSIGNEE'S expense, perform any acts which are necessary in connection with the prosecution of patent applications or intellectual property and/or the enforcement of patents or other rights resulting from such applications or intellectual property.

Covenants and agrees that Assignor has full right to convey the entire interest herein assigned, and that Assignor has not executed, and will not execute, any agreement in conflict herewith.


Further covenants and agrees that Assignor will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known to Assignor respecting said

invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper protection for said invention in all countries.

Grants all attorneys associated with Customer Number 56719 power to insert in this assignment any further identification that may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
