**ASSIGNMENT  
OF PATENT RIGHTS**

PATENT

This **ASSIGNMENT**, effective the 28th day of June, 2017 ("**Effective Date**") by and between Rodriguez Company, Inc. d/b/a Santa Fe Ingredients, an Arizona corporation having a place of business at 1358 Highway 338, Animas, New Mexico, 88020 ("**Assignor**") and Henry Rodriguez, an individual residing at 1358 Highway 338, Animas, New Mexico, 88020 ("**Assignee**"). Assignor on the one hand, and Assignee on the other hand, are each sometimes referred to herein as a "**Party**" and collectively as the "**Parties**" to this Agreement.

**WHEREAS**, Assignor is the owner of the entire right, title and interest in and to the patents and patent applications, and the inventions disclosed therein, which are identified on the attached Patent Schedule (hereinafter referred to collectively as the "Patent Rights").

**WHEREAS**, Assignee is desirous of obtaining all right, title and interest in and to the inventions covered by the Patent Rights throughout the world, including but not limited to the United States and Mexico.

**WHEREAS**, Assignor agrees to assign the Patent Rights throughout the world, including but not limited to the United States and Mexico, to Assignee.

**NOW THEREFORE**, in consideration of good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignment: Assignor hereby absolutely, irrevocably, and unconditionally assigns and transfers to Assignee its entire right, title, and interest in and to the Patent Rights as of the Effective Date, including any and all extensions, divisions, reissues, substitutes, renewals or continuations of the Patent Rights; the right to sue or otherwise bring an action and to collect and receive damages for infringement of any of the Patent Rights; any and all priority rights under all available international agreements, treaties, and conventions for the protection of intellectual property in its various forms, and all applications for patents (including related rights such as utility-model registrations, inventor's certificates, industrial design registrations, and the like) heretofore or hereafter filed for said Patent Rights.




3. Successors and Assigns. The terms and conditions of this Agreement will inure to the benefit of, and be binding upon, the respective successors, assigns, and legal representatives of the Parties.

4. Further Assurances. Assignor shall sign (or cause to be signed) all further documents, do (or cause to be done) all further acts, and provide all assurances as may reasonably be necessary or desirable to give effect to the terms of this Agreement.
