**RELEASE OF SECURITY INTEREST  
IN PATENT COLLATERAL**

This RELEASE OF SECURITY INTEREST IN PATENT COLLATERAL, dated as of June 21, 2017 (this "Release"), is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, successor by merger to WACHOVIA BANK, NATIONAL ASSOCIATION, as agent (in such capacity, the "Agent"), in favor of SAFWAY SERVICES, LLC, a Delaware limited liability company (the "Debtor"), as follows:

**W I T N E S S E T H**

WHEREAS, pursuant to the Patent Collateral Assignment and Security Agreement, dated December 16, 2009 (the "Patent Security Agreement"), and recorded with the U.S. Patent and Trademark Office on December 18, 2009 at Reel/Frame 023699/0262, as security for the payment and performance of all Obligations, the Debtor granted to the Agent, for itself and the benefit of the Secured Parties, a security interest in all of the following then owned or at any time thereafter acquired or existing (collectively, the "Released Patent Collateral"):

(a) all of Debtor's now existing or hereafter acquired right, title and interest in and to all of Debtor's interest in any patents; all applications, registrations and recordings relating to such patents in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof, any political subdivision thereof or in any other countries, and all reissues, extensions and renewals thereof including, without limitation, those patents, applications, registrations and recordings described on Exhibit A hereto (the "Patents"), and

(b) any and all proceeds of any of the foregoing, including, without limitation, any claims by Debtor against third parties for infringement of the Patents or any licenses with respect thereto.

WHEREAS, the Debtor has requested that the Agent release its security interest in all of the Debtor's right, title or interest in or to the Released Patent Collateral.

NOW, THEREFORE, the Agent, without recourse, representation or warranty of any kind or nature, and at the Debtor's sole cost and expense, hereby terminates, cancels and releases its security interest in all of the Debtor's right, title and interest in or to the Released Patent Collateral, including the patents listed on Exhibit A hereto, and any and all right, title and interest of the Agent in the Released Patent Collateral shall hereby terminate, cease and become void.

The Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.

The validity, interpretation and enforcement of this Release and any dispute arising out of the relationship between the parties hereto, whether in contract, tort, equity or otherwise, shall be governed by and construed in accordance with the laws of the State of New York.

Capitalized terms used but not defined herein shall have the meanings given to them in the Patent Security Agreement.
