# RELEASE OF SECURITY INTEREST IN PATENT COLLATERAL

WHEREAS, the Grantor has requested that the Agent release its security interest in all of the Grantor's right, title or interest in or to the Released Patent Collateral.

NOW, THEREFORE, the Agent, on behalf of itself, its successors, legal representatives and assigns and any lenders for which the Agent acted as security or collateral agent, without recourse, representation or warranty of any kind or nature, and at the Grantor's sole cost and expense, hereby terminates, cancels and releases its security interest in all of the Grantor's right, title and interest in or to the Released Patent Collateral, including the patents listed on Exhibit A hereto, and any and all right, title and interest of the Agent in the Released Patent Collateral shall hereby terminate, cease and become void.
