AND Assignors hereby request the Commissioner of Patent and Trademarks to issue said Letters Patent of the United States to Assignee, as Assignee of said inventions and the


Letters Patent to be issued thereon, for the sole use and benefit of Assignee, its successors, legal representatives and assigns.
