residing at **Washington, IL**


having invented an improvement **BIO-BASED COMPOSITES, COMPOSITE MATERIALS, AND ADHESIVES**

for which I (we) have made application for Letters Patent of the United States, identified as Department of Agriculture Case No **0166.16**


