### ASSIGNMENT OF INVENTION

WHEREAS, I, Annie Larouche, 480, Preston, Mascouche, Quebec, Canada J7L 3V3, have invented certain new and ornamental improvements in the following: (1) **SWIMMING POOL LEAF TOOL**; (2) **SWIMMING POOL BRUSH**; (3) **SWIMMING POOL TELESCOPING POLE**; (4) **SWIMMING POOL THERMOMETER**; (5) **SWIMMING POOL CHLORINE DISPENSER**; AND (6) **SWIMMING POOL VACUUM** for which respective design patent applications for Letters Patent in the United States is being filed.


AND WHEREAS, at the time the improvements were made, I was under an obligation to assign all of my right, title, and interest in said improvements to the ASSIGNEE.



And I hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Letters Patent to said ASSIGNEE as the assignee of my whole right, title, and interest thereto.

And I further agree to sign and properly execute such necessary and lawful papers for application for patents, for filing subdivisions of said applications for patents, and for obtaining any reissue or reissues of any Letters Patent which may be granted for my aforesaid improvements, as the assignee thereof shall hereafter require and prepare at its own expense.
