WHEREAS the below-named Inventors desire to sell, assign, and transfer all of their rights, title, and interest, for all countries in and to certain inventions relating to the Inventions subject to the previously assigned rights, title, and interest by the Move Inventors; and

WHEREAS the below-named Assignees desire to obtain the Inventors' rights to the Inventions as joint owners of the Inventions subject to the previously assigned rights, title, and interest by the Move Inventors.

NOW THEREFORE, for and in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby expressly acknowledged, the Parties agree as follows:

1. Each undersigned inventor agrees to sell, assign, and transfer, and does hereby sell, assign and transfer unto:

Squeezable Beverage Bottle and Filter System

described in: U.S. Provisional Application No. 61/304,216, filed on February 12, 2010; U.S. Utility Patent Application No. 12/854,721, filed on August 11, 2010; PCT Application No. PCT/US11/24607, filed on February 11, 2011; Argentina Patent Application No. 20110100448, filed on February 14, 2011; and a Taiwan Patent Application filed on February 14, 2011, and the invention(s) and improvement(s) set forth therein, and any and all patent applications claiming the benefit to any of the above, and any and all continuations, continuations-in-part, divisionals, and renewals of and substitutes for any and all patent applications claiming the benefit of any of the above, and all the rights and privileges under any and all Letters Patent that may be granted therefor in any country, and any reissues, or reexaminations, or extensions of said Letters Patent in which inventorship includes at least one inventor other than the Move Inventors (collectively referred to as "the Utility Patent Group").

2. The Inventors request that any and all Letters Patent for said inventions in the Utility Patent Group be issued to said Assignees, their successors, assigns and legal representatives, or to such nominees as either Assignee may designate.

3. The Inventors agree that, when requested, we will, without charge to said Assignees but at their expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining patents for said inventions in the Utility Patent Group in any and all countries and for vesting title thereto in said Assignees, their successors, assigns and legal representatives or nominees.
4. The Inventors authorize and empower the Assignees, their successors, assigns and legal representatives or nominees, to invoke and claim for any application for patent or other form of protection for said inventions in the Utility Patent Group filed by them, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it, and to invoke and claim such right of priority without further written or oral authorization from us.
5. The Inventors hereby consent that a copy of this assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document which may be required in any country for any purpose and more particularly in proof of the right of the Assignees or nominee to claim the aforesaid benefit of the right of priority provided by the International convention which may henceforth be substituted for it.
6. The Parties agree that any and all previous conveyances of some or all of the rights to any and all applications in the Utility Patent Group by one or more of any of the undersigned inventors are hereby revoked and rescinded in preference of the rights conveyed by this assignment.
7. The Inventors covenant with the Assignees, their successors, assigns and legal representatives, that the rights and property herein conveyed are free and clear of any encumbrance, and that we have full right to convey the same as herein expressed.
8. Precision Thermoplastic Components Inc., an Ohio corporation with an address at 3765 Saint Johns Road, Lima, OH 45806, and the employer of inventors Randy E. Carter and Brian D. Schumacher, hereby acknowledges and agrees, for itself and any affiliates or subsidiaries, that it has no right, title or interest in and to the Inventions and the Utility Patent Group herein assigned.

The Parties hereby covenant and agree that Move Collective LLC remains the sole owner of, and retains exclusive rights, throughout any and all countries in which Letters Patent have been or will be issued, to make, use, and sell bottles, squeezable bottles, bottle filters, and any combinations thereof having features protected by one or more of U.S. Design Patent Nos. D621660, D620758, D631285, and D631286, and various foreign patents and registrations deriving therefrom, relating, in general terms, to the hourglass-like shape bottles and/or the filter housing design and substantially similar appearances thereof (referred to as "Move's Exclusive Field of Use").
10. The Parties hereby covenant and agree that Pure Water Global, Inc. has no right to exploit, convey, or otherwise transfer any rights provided by any of the Letters Patent of the Utility Patent Group within Move's Exclusive Field of Use without express written consent of Move Collective LLC.



