**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN PATENT RIGHTS**

TERMINATION AND RELEASE dated as of June 30, 2017, from JPMORGAN CHASE BANK, N.A., as Administrative Agent for itself and certain lenders (the "Administrative Agent") in favor of the owners of the Patents set forth on Schedule A hereto.

WITNESSETH:

WHEREAS, pursuant to the Pledge and Security Agreement, dated as of June 4, 2013, in favor of the Administrative Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Security Agreement"), YellowPages.com LLC, a Delaware limited liability company ("Grantor") granted a security interest (the "Security Interest") to the Administrative Agent in all Patents;

WHEREAS, pursuant to that certain Grant of Security Interest in Patent Rights effective as of June 4, 2013, among the Administrative Agent and Grantor (the "Patent Security Agreement"), Grantor, by reference to the Security Agreement, reaffirmed its intent to grant the Security Interest to the Administrative Agent specifically in certain Collateral (as that term is defined in the Patent Security Agreement), including the Patents set forth on Schedule A hereto (the "Patent Collateral");

WHEREAS, the Patent Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on July 3, 2013 at Reel 030746 and Frame 0584; and


WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Patent Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby states as follows:

1. Definitions. Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Patent Security Agreement.
2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges, without recourse, representation or warranty, its Security Interest in the Patent Collateral, and any right, title or interest of the Administrative Agent in such Patent Collateral shall hereby cease and become void.
3. Further Assurances. The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
