CONFIRMATORY ASSIGNMENT

WHEREAS I/WE Alexander Charles WEYMOUTH-WILSON, James BOYDELL, and Laura WALLIS all British citizens, **Zofia KOMSTA** a Polish citizen all c/o Dextra Laboratories Ltd, Science & Technology Centre, Earley Gate, Whiteknights Road, Reading, RG6 6BZ, United Kingdom, and **Ieuan DAVIES** a British citizen c/o New Zealand Pharmaceuticals Ltd, 68 Weld Street, RD2 Palmerston North 4472, New Zealand (hereinafter called the "**Inventors**") have invented or discovered (together with others) "**COMPOUNDS**" (hereinafter called the "**Invention**") for which a PCT patent application was filed at the Intellectual Property Office in the United Kingdom as receiving Office under number PCT/GB2015/053518 on 19 November 2015 and a patent application was filed in Taiwan under number 104138185 on 19 November 2015, both claiming priority to UK patent application 1420593.4 filed on 19 November 2014, UK patent application 1420594.2 filed on 19 November 2014 and UK patent application 1505676.5 filed on 01 April 2015 (hereinafter called the "**Applications**");

WHEREAS James BOYDELL, Laura WALLIS, Zofia KOMSTA and Ieuan DAVIES were employed at the time of making of the **Invention** by Dextra Laboratories Ltd, Science & Technology Centre, Earley Gate, Whiteknights Road, Reading, RG6 6BZ, United Kingdom (English company number 02420895) ("**Dextra**") and whereas the **Invention** was made in the course of employment under circumstances whereby an invention may reasonably be expected to result, and all rights in and to the **Invention** were assigned to **Dextra** by operation of law, specifically s39 of the Patents Act 1977, and moreover by virtue of a specific assignment clause in their contracts of employment;

WHEREAS Alexander Charles WEYMOUTH-WILSON was Director of **Dextra** at the time of making the **Invention** and whereas the **Invention** was made in the course of his normal duties as a Director of **Dextra** or in the course of duties falling outside his normal duties, but specifically assigned to him, and the circumstances were such that an invention might reasonably be expected to result from the carrying out of his duties, or that the **Invention** was made in the course of his duties and at the time of making the **Invention**, because of the nature of his duties and the particular responsibilities arising from the nature of his duties as a director he had a special obligation to further the interests of **Dextra's** undertaking, and:


WHEREAS **Dextra** is desirous of confirming its entitlements in and to the **Invention** and in and to the **Applications**;

NOW, THEREFORE, to all whom it may concern be it known that for consideration of the amounts set out in the aforementioned contracts of employment and the sum of £1 (one pound sterling) the sufficiency of which is hereby acknowledged, I/we the **Inventors** hereby confirm the ownership by **Dextra** of the **Invention** and the **Applications** and hereby assign and transfer to **Dextra** all ownership right, title and interest in and to the **Invention** and the **Applications** and to any priority rights for all territories of the world in respect of the **Invention** and the **Applications** and in and to any divisional application, continuation or continuation in part application thereof, and in and to any extension, or re-issue thereof, or Supplementary Protection Certificate based thereon, and I/we the **Inventors** hereby authorise and request any patent arising therefrom in any territory of the world be issued to **Dextra**, its successors and assigns;

AND I/we the **Inventors** for ourselves and our respective executors and legal representatives hereby agree to provide information and to make, execute and deliver any and all other instruments in writing, and any and all further acts, applications, papers, affidavits, assignments and other documents which may be possible and are necessary or desirable to more effectually secure to and vest in **Dextra**, its successors and assigns, the whole right, title and interest in and to the **Invention** and the **Applications**


