AUTHORIZE the ASSIGNEE to apply for and receive in any jurisdiction, in its own name, any and all patents or their legal equivalents relating to the Improvements;

AUTHORIZE AND REQUEST the issuing authority in any jurisdiction to issue any and all patents or their legal equivalents relating to any of the Improvements to and in the name of the ASSIGNEE;



COVENANT, when requested and at the expense of the ASSIGNEE, to carry out in good faith the intent and purpose of this Assignment, to execute all divisional, continuing, substitute, renewal, reissue, and all other applications for patents or their legal equivalents relating to any and all of the Improvements; to execute all rightful oaths, declarations, powers of attorney, assignments and other papers; to communicate to the ASSIGNEE all facts and provide to the ASSIGNEE all documents and things known and accessible to the ASSIGNOR relating to the Intellectual Property Rights, including, but not limited to, the Improvements, the '800 Application, the Related Applications, and the histories thereof, and to testify as to the same in any interference, derivation or review proceeding, litigation or other proceeding relating to the any of the Intellectual Property Rights, including, but not limited to, any of the Improvements, the '800 Application, any Related Application, and/or the history of any of the foregoing, and

generally to do everything possible which the ASSIGNEE shall consider desirable for vesting title to all of the Intellectual Property Rights in the ASSIGNEE, and to secure, maintain, defend and enforce valid and enforceable patent protection for the Improvements;

AGREE AND ACKNOWLEDGE that the SALE, ASSIGNMENT AND TRANSFER of the Intellectual Property Rights, as set forth herein, is and shall be IRREVOCABLE and BINDING upon the heirs, assigns, representatives and successors of the ASSIGNOR and EXTEND to the successors, assigns and nominees of the ASSIGNEE.
