Whereas:

- A. The Assignor has applied to the Intellectual Property Office of Singapore for patents under Patents Act (Cap 221; Revised Edition 2005) and has been assigned Application Numbers listed in the Schedule A ('the Applications') further particulars of which are in the Schedule in respect of the Inventions, respectively disclosed in the Applications ('the Inventions').
- B. The Assignor has agreed to assign to the Assignee the Inventions and the Applications and all its rights, title and interest therein upon the terms and conditions set out below.

 - 1.2 all the rights of the Assignor in and to the Applications and the full and exclusive benefit of them and all rights privileges and advantages associated with them;
 - 1.3 the full right to apply for and obtain patents or other similar forms of protection in respect of the Inventions throughout the world;
 - 1.4 the right to make any new application or applications in respect of any part or parts of the subject matter of any application or specification filed in connection with the Inventions in Singapore and the right to claim priority under section 17 Patents Act from the Applications;

- 1.5 any patents under the Patents Act (Cap 221) or other similar forms of protection granted in respect of the Inventions in Singapore pursuant to the Applications;
- 1.6 the right to bring proceedings (in Singapore under sections 67 or 76 Patents Act) for any previous infringement of the rights assigned by this Assignment; and
- 1.7 the right to claim priority of the Applications under the Paris Convention (as amended) or Patent Corporation Treaty when making applications in countries or territories outside Singapore.

TO HOLD the same unto the Assignee absolutely.

2. The Assignor HEREBY COVENANTS with the Assignee will at the expense of the Assignee execute, sign and do all such instruments, applications, documents, acts and things as may be required by the Assignee to enable the Assignee (or the nominee of the Assignee) to enjoy the full benefit of the property and rights hereby assigned and (if requested to do so by the Assignee) to apply for any patents or other forms of protection in respect of the Invention throughout the world and fully and effectively to vest the same in the Assignee or as the Assignee shall direct.


