PATENT ASSIGNMENT

This Patent Assignment is entered into by and between Dana Heavy Vehicle Systems Group, LLC, an Ohio limited liability company with a principal place of business at 3939 Technology Drive, Maumee, Ohio 43537 ("Assignor"), and Schafer Driveline LLC, an Indiana limited liability company with a principal place of business of 123 Phoenix Place, Fredericktown, Ohio 43019 ("Assignee").

WHEREAS, Dana Holding Corporation, a Delaware corporation ("Dana"), Dana Off Highway Products, LLC, an Ohio limited liability company ("DOHP"), Assignee and Schafer Gear Works, Inc., an Indiana corporation and the direct parent of Assignee, have entered into that certain Asset Purchase Agreement, dated as of August 17, 2012 (the "Purchase Agreement");

WHEREAS, pursuant to the terms and conditions of Purchase Agreement, Assignor agrees to transfer the Patents to Assignee and Assignee is desirous of acquiring the entire right, title, and interest in and to the Patents.

NOW, THEREFORE, in consideration of good and valuable consideration received by Assignor, Assignor does hereby sell, assign, transfer, and set over unto Assignee, its successors and assigns, the entire right, title, and interest in and to said Patents and all invention or inventions, as described therein, in any form or embodiment thereof, and in and to the Patents; and in and to any application filed in any foreign country based thereon, including the right to file said foreign applications under the provisions of the International Convention; also the entire right, title, and interest in and to any and all patents, reissues, reexaminations or extensions thereof to be obtained in this or any foreign country upon said invention or inventions and any divisional, continuation, continuation-in-part, or substitute applications which may be filed upon said invention or inventions in this or any foreign country; and Assignor hereby authorizes and requests the issuing authority to issue any and all Patents to Assignee or its successors and assigns.
