The undersigned, for purposes of amending the Fourth Amended and Restated Certificate of Incorporation (the "Certificate") of Catheter Robotics Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "DGCL"), does hereby certify as follows:

FIRST: The name of the corporation is Catheter Robotics Inc. (the "Corporation") and that the Corporation was originally incorporated pursuant to the DGCL on September 8, 2006 under the name Catheter Robotics Inc.

SECOND: That an Amended and Restated Certificate of Incorporation was filed with the State of Delaware on November 16, 2010, that a further Amended and Restated Certificate of Incorporation was filed with the State of Delaware on December 1, 2011, that a further Amended and Restated Certificate of Incorporation was filed with the State of Delaware on December 9, 2011 and that a further Amended and Restated Certificate of Incorporation was filed with the State of Delaware on August 1, 2013.

THIRD: Article FIRST of the Certificate is hereby amended to read, in its entirety, as follows:

"The name of this corporation is Catheter Precision, Inc. (the "**Corporation**")."

FOURTH: The foregoing amendment was duly adopted by the Board of Directors of the Corporation in accordance with the applicable provisions of Section 242 of the DGCL.
